I mean it's obvious. I mean, I've said this before, it's obvious there's a a concert conservative effort, conservative conservative effort to drive my family out of the county. That there's a group of individuals and we're discovering more and more of them who are involved are being managed by someone. Here is part of this plan to drive us out of county there's it's pretty obvious. I need to I need to Bice it's been a real big problem. She's counting zoning problem. She is being controlled by the hallux across the road, who were best friends with Abernathy through going to the headaches we saw I saw Mr. has a brand new came flying down the road he brought it was funny and blew the speed limit on the road all the time. All these people they violate the law all the time. But because they're friends with the sheriff, they don't nothing. Nothing ever happened. So where I've been where my little I mean it was a mistake. I read the law misunderstood that law. I'm thrown in I almost got tased I'm being by police. And this is all as a direct result of Abernathy and Doug Matthews.
