And they've even you know, they raided my house without a warrant at my house without a warrant. and they couldn't see inside the doors or they didn't have renamed And they even rented the wrong house. So I was at that time I was in. But this time, you know, they came after me and they're trying to you know, they're trying to put me in And they were temporarily successful. I was detained for a new for three charges, all of which were It was I mean, I've been shooting rifles in the same location now for seven years. No one's ever had a problem. But then all of a suddenly these people come in and they steal our home from us, and they steal our land and, and do all this stuff. Now they have a problem with it. So we it's a you know, so we got And I had about five I've actually week from today, at 5pm. I was arrested by the Marconi Sheriff's Office. And then I was thrown into solitary confinement for seven hours. And then I was booked into at 2am in the morning and remain there for the entire stint was for 52 hours, which is well beyond the what is allowed. And excessive force. The officer even had pulled it had pulled his taser on me at one point during the altercation. So it is excessive use of force. You know, I you know, they were when they arrived, I knew they were going to do I mean that's what they were for. I had two officers One was named author hold. I need to find the senior officer that was there because the senior officer there was really the one that was there was responsible for the action. These are all people that are friends and connections of Abernathy. And this is what it was was a hit. It was a hit And my entire time since I spent inside prison I was someone had their thumb on me the entire time. And these are all pollute. You know, these are political hits and bias and partisan. And there's no doubt about it. This is not the first time they've shown it and it's not the first time they've done it. But because of this time they they brought because this time is they're going to try to charge me with these with these acts. It's

gonna go to court. So it's going to force the issue of everything else. So we're going to probably be filing a civil rights lawsuit [REDACTED] the Sheriff's Department. I tried to get it stopped. Because I didn't I've been talking to [REDACTED] orange about I've been talking about it, everybody for years. And so it's now it's time to do something about it. It's past time. So why are you stalking me in front of my [REDACTED] Why are you driving down slowing slow down and stalking so here she comes [REDACTED] in her car [REDACTED] So that's [REDACTED] being taught [REDACTED] twice, double [REDACTED] So yeah, there's all they're doing. Yeah, the officer Paul, as soon as the officer pulled up, all I said was I [REDACTED] repeatedly said as you do there, you know, either charged me with something or let me go No. I'm not gonna get into an argument about it. And so he [REDACTED] started me with a predicate Bolton so fabricated [REDACTED] The officers were not there to me actually discharging any firearm. So the only witness they have are the people that are stalking me that I have evidence or stalking me across the street. So I can't really even use those as people's witnesses. Because they have expressed a bias and partisan to [REDACTED] us. We have evidence of them [REDACTED] us. We have evidence of them shouting at us. So yeah, so this is gonna be very difficult for them to I mean, they can't use them as witnesses because they're obviously bias partisan postal. So and the other thing is, is the these it was a public highway. Well, I don't live by Humber public highway. Thanks that roads only been paid for maybe seven years.
